Protocol on Scientific and Educational Cooperation

Between

Roskilde University, Kingdom of Denmark

and

Siberian State Academy of Geodesy, Novosibirsk, Russia

Roskilde University (Kingdom of Denmark), further referred to as "Party 1" and Siberian State
Academy of Geodesy, Novosibirsk, Russia, further referred to as "Party 2", both referred to as
"Parties", recognizing the necessity of intense cooperation under conditions of rapidly developing
science and innovation, and realizing the importance of joint research activity, agree on the following:

Article 1. Subject of Protocol

The parties agree to establish an academic relationship for the purpose of carrying out a bilateral cooperation program in all fields of mutual interest. Cooperation projects between the parties shall be described in specific agreements. At each occasion, such documents shall be submitted to the parties for approval and formal definition of organizational and funding aspects.

The parties agree to encourage the following:

- 1.1. Exchange of faculty and university staff;
- 1.2. Exchange of students;
- 1.3. Joint development of curriculum and syllabi;
- 1.4. Joint research activity and scientific projects;
- 1.5. Joint organization of conferences, seminars and academic meetings;
- 1.6. Exchange of research publications, books and materials;
- 1.7. Special short-term training programs and short term on-line courses;
- 1.8. Educators' training courses;
- 1.9. Organization of summer courses.

The list of cooperation areas and relevant conditions for the cooperation may be extended and specified on the Parties' agreement.

Article 2. Duration of Protocol and Other Terms

- 2.1. The present Protocol comes into effect upon its signature by each of the Party and remains in effect for 5 years from the day of its signature.
- 2.2. The present Protocol may be renewed unless a Party states in writing about its termination.

 Any of the Party can terminate the present Protocol at any time with a six months' written notification to the other Party. Any alterations and (or) amendments of the present Protocol may come into effect only on mutual agreement as presented in written form by the Parties'

- authorized representatives.
- 2.3. Apart from the provisions stated above, the present Protocol does not impose any financial liability on the Parties.
- 2.4. The provisions not regulated by the present Protocol can be discussed separately by both Parties without amending the present Protocol. Alterations and amendments to the present Protocol are to be made only on both Parties' agreement.
- 2.5. The Protocol is signed by the official representatives of both Parties. 2 copies in English are to be made, one for each Party.
